By joining the PBCC's **Legacy Giving Circle**, you are making a lasting impact in the fight against breast cancer. Your legacy will bring hope to future generations.



Our Commitment

We are committed to working with you to create a charitable plan that reflects your values and meets your needs. Together, we can establish a meaningful philanthropic legacy that supports the PBCC’s mission.



Types of Legacy Gifts

Bequests

A gift made through your will or trust, where you designate a specific amount, percentage, or asset to the PA Breast Cancer Coalition after your lifetime.



Retirement Account Beneficiaries

You can designate the PA Breast Cancer Coalition as a beneficiary of your retirement plan (ex. IRA, 401(k), or pension), ensuring your legacy supports the mission.



Life Insurance Policies

You can name the PBCC as a beneficiary of a life insurance policy, making a meaningful gift while potentially reducing estate taxes.



Charitable Remainder Trusts

This type of trust allows you to donate assets while receiving income for a period of time, with the remainder benefiting the PA Breast Cancer Coalition.



Charitable Gift Annuities

A gift that provides you with income for life, with the remainder going to the PBCC after your passing.



Donor-Advised Funds

A charitable giving vehicle that allows you to contribute assets to a fund, which then distributes donations to the PBCC or other organizations according to your wishes.



Let us know about your gift

It can often be difficult to plan and make sure your gifts are used in line with your wishes if they are left unknown. More importantly, the PBCC wants to thank you for considering our work as part of your legacy.

We know that life circumstances can change and you may need to alter or reconsider your gift in the future. That's all right — reporting your gift today does not obligate you now nor in the future.

Sample Bequest Language

Percentage of Estate for Unrestricted Purposes

I give, devise, and bequeath to the Pennsylvania Breast Cancer Coalition, a Pennsylvania nonprofit organization located in Lebanon, PA, or its successor in interest, ____% of the rest, residue, and remainder of my estate as an unrestricted gift to be used for the general purposes of the Pennsylvania Breast Cancer Coalition.

I instruct that all my charitable gifts shall be made, to the extent possible, from property that constitutes "income in respect of a decedent" as that term is defined in the Internal Revenue Code.

Specific Amount for Unrestricted Purposes

I give, devise, and bequeath to the Pennsylvania Breast Cancer Coalition, a Pennsylvania nonprofit organization located in Lebanon, PA, or its successor in interest, \$ ____ as an unrestricted gift to be used for the general purposes of the Pennsylvania Breast Cancer Coalition.

I instruct that all my charitable gifts shall be made, to the extent possible, from property that constitutes "income in respect of a decedent" as that term is defined in the Internal Revenue Code.
