# BREAST CANCER COALITION Breast Cancer License Plate Frequently Asked Questions

## When will I receive my plate? How long does the license plate application process take?

The PA Breast Cancer Coalition sends applications to PennDOT twice a month. The plate will arrive in your mailbox approximately 6-8 weeks from when PennDOT receives your application.

#### How do I order extra registration cards?

You will receive one registration card automatically with your purchase of an awareness plate. If you wish to have extra copies, please indicate how many EXTRA cards you would like at the end of Section A on the PennDOT application and add \$2.00 for each extra card ordered. If you only need one registration card, please leave this line blank.

## My registration is due soon (or I just renewed my registration). What should I do?

Please do not let your registration lapse. Purchasing the breast cancer awareness plate does not automatically renew your registration. The one-time fee covers the cost of the new plate, not the annual registration fee.

If your registration expires within the next few months, we recommend you renew your registration first. Once your new sticker arrives, put it on your current plate. At that point, you may apply for the breast cancer awareness plate. When your new plate arrives, it will come with a new sticker and registration card. This ensures that PennDOT is not processing both your registration renewal AND application for a new plate at the same time.

## Can I order the breast cancer awareness plate as a gift for someone?

You may pay the fee for someone else's specialty plate, but a registered owner of the vehicle needs to sign the application.

## Can I choose my own numbers or personalize the license plate?

Yes, an additional fee is required. The total cost of a personalized PBCC breast cancer license plate is \$200.

## I have a Person with Disability license plate. Can I get the breast cancer awareness plate with this logo?

PennDOT will not offer any specialty plate with the Person with Disability insignia. A customer can apply for the breast cancer awareness plate and apply for a Person with Disability placard, which hangs on the rearview mirror. This will afford you the same parking privileges as a Person with Disability plate while still supporting the PA Breast Cancer Coalition. If you wish to apply for the placard, visit the PennDOT website (www.dmv.state.pa.us) and download form MV-145A.

## Do I need to be a member of the PBCC to order this plate?

The General Information section of the PennDOT application mentions being a member of the organization. This is standard PennDOT language which we are not permitted to revise. The PA Breast Cancer Coalition does not have memberships. Anyone living in Pennsylvania can order the breast cancer awareness license plate, as long as your vehicle meets the other requirements listed on the PennDOT application.

PennDOT charges a Special Organization Issuance Fee. Participating organizations may charge an initial fee above the PennDOT fee. The organization fee is \$<u>16.00</u>. Therefore, the total fee due with this application is \$<u>50.00</u>. Fees must be made payable to the organization name of Pennsylvania Breast Cancer Coalition

**NOTE:** Special organizations with more than 2,000 organization registration plates may charge a renewal fee for authorization of or continued use of the special organization registration plate. This fee is separate from PennDOT's registration renewal fee. The renewal fee is at the organization's discretion and is not related to PennDOT.

#### **GENERAL INFORMATION REGARDING A SPECIAL ORGANIZATION REGISTRATION PLATE**

#### • PLEASE ALLOW 4-6 WEEKS FOR DELIVERY.

- This application, with Sections A, D (if applicable), and E, completed in full, must be returned to the organization official for submission to PennDOT. No applications sent directly to PennDOT by the organization member will be processed. The organization must complete Sections B and C. NOTE: Only applications for Volunteer Fire Fighter and Emergency Medical Services special organization registration plates may be mailed directly to PennDOT by the customer.
- To replace a lost, stolen or defaced registration plate that is damaged, but not beyond recognition, complete and submit <u>MV-44</u>. "Application for <u>Duplicate Registration Card or Replacement of Lost</u>, <u>Stolen or Defaced Registration Plate</u>." along with a photograph or tracing of the registration plate for identification purposes. A registration plate is considered to be defaced when the registration plate is damaged by a specific incident such as a traffic accident, cutting, scraping or damaged caused by intense cleaning or harmful chemicals. There is a fee to replace a defaced standard issue or specialty registration plate. If your registration plate is a personalized registration plate, it will be replaced with the same configuration as before at no cost. Personalized registration plates that are lost or stolen are not able to be replaced with the same configuration. If your personalized registration plate will be produced with the new configuration plate, however, customers will be required to select a new configuration. The registration plate on the front of the <u>MV-44</u>. If an immediate replacement registration plate is needed while waiting for your replacement personalized registration plate will be issued until the replacement personalized, lost or stolen registration plate fee. A standard issue registration plate will be issued until the replacement personalized, lost or stolen registration plate can be provided. **NOTE**: The replacement standard issue registration plate will take approximately 6-8 weeks to receive in the mail from the time PennDOT receives and processes the application.
- To apply for a **free registration plate**, due to current plate being illegible, the vehicle owner should visit our website at <u>www.pa.gov/dmv</u> and take <u>Form</u> <u>MV-46</u>, "Application to <u>Replace an Illegible Registration Plate,"</u> to any official Pennsylvania inspection station for verification that their registration plate is illegible OR have a law enforcement official verify the need for a replacement registration plate on <u>Form MV-46</u>. The vehicle owner is then responsible for signing and returning the completed <u>Form MV-46</u> to PennDOT in order to receive a replacement registration plate free of charge. Your registration plate will be replaced with the next registration plate in the series and with the same style of registration plate you are replacing. If your registration plate is currently personalized, PennDOT will replace it with the same style and configuration as the registration plate you are replacing. If replacing your personalized registration plate, please attach a photograph or tracing of the registration plate for identification purposes. **If an immediate replacement registration plate is needed while waiting for your illegible personalized registration plate, please complete and submit Form MV-44, "Application for Duplicate Registration Card or Replacement of Lost, Stolen or Defaced Registration Plate," and the replacement registration plate fee. A standard issue registration plate will be issued until the replacement personalized registration plate can be provided. NOTE: The replacement registration plate will take approximately 6-8 weeks to receive in the mail from the time PennDOT receives and processes the application. <b>NOTE:** The replacement registration plate will take approximately 7-10 business days to receive in the mail from the time PennDOT receives and processes the application. Please allow 8-10 weeks for delivery of personalized plates.
- To apply for a never received product, the vehicle owner should visit our website at <u>www.pa.gov/dmv</u> and complete <u>Form MV-50</u>, "<u>Application for</u> <u>Replacement of a Never Received Product.</u>" By law, customers are entitled to a free reissuance of a product they never received if an application for a never received product is submitted within 90 days of the original issuance date. If a customer submits the application outside of the 90 days, the customer must submit the required fee for each never received registration card requested and the required fee for each never received registration plate requested, along with this application.
- Requests for special organization registration plates are restricted to passenger vehicles, trucks with a registered gross weight of not more than **14,000 lbs**., trailers, motorcycles and motor homes. **NOTE:** Motorcycle registration plates are only available if the organization has an approved motorcycle special organization registration plate.
- NO REFUND of the fee will be issued when an applicant cancels a request after the order is placed.
- When the applicant ceases to be a member in the organization as listed in Section B, the registration plate must be returned to PennDOT. Complete Form MV-44 and submit a fee for the issuance of a regular series registration plate.
- Special organization registration plates are issued in number sequence unless requesting personalization in Section D.
- To avoid possible problems with citations with your old registration plate, return it to: Bureau of Motor Vehicles, Return Tag Unit, P.O. Box 68597, Harrisburg, PA 17106-8597 after you have received your special organization registration plate.

#### IF PERSONALIZING YOUR SPECIAL ORGANIZATION REGISTRATION PLATE

- The registration on your vehicle must be current in order for PennDOT to process your request. There is a fee to personalize your special organization registration plate. The additional fee covers the cost of your personalized registration plate order only and will not renew your vehicle's registration. To renew your registration, please include your completed renewal application, Form MV-105, "Pennsylvania Registration Renewal Application," or Form MV-140, "Request for Registration," and a separate check or money order in the amount of your registration renewal fee. Payment is to be made by check or money order payable to the Commonwealth of Pennsylvania. PLEASE DO NOT SEND CASH.
- When requesting a numeric character of zero, please list as "Ø" instead of the alpha character of "O."
- · PennDOT reserves the right to limit or reject requests.
- To check personalized registration plate availability, visit PennDOT's Driver and Vehicle Services website, <u>www.pa.gov/dmv</u>, and select Vehicle Services then Registration Plates and select <u>Personalized Registration Plates</u>. Personalized registration plates will not be reserved until PennDOT receives payment and a completed application, and approves your requested registration plate configuration [number(s) and/or letter(s)]. Please note that registration plate requests are processed on a first-come, first-served basis. Although a requested registration plate configuration may show as being available on the website, it is possible that a request for the same registration plate configuration plate
- Personalized registration plates will be manufactured on the basis of this application. NO REFUND of the fee will be issued when an applicant cancels a request after the order is placed with the manufacturer.
- Allow 8 to 10 weeks for delivery of personalized special organization registration plate.
